**LIMITED TENDER NOTICE**

Sealed Tenders are hereby invited by **The Commandant, 11 Bn NDRF**, M A Road, Chowkaghat, Varanasi-221002 (UP) on behalf of the President of India for procurement of **REGULAR OXYGEN LSP# 170-020 WITH LIGHT WEIGHT OXYGEN CYLINDER** for **National Disaster Response Force**, Varanasi. Estimated cost of Stores is Rs. **6,50,000/-** (Rupees six lakhs fifty thousand) only.

**INSTRUCTIONS TO BIDDERS & CONDITIONS OF CONTRACT**

1. Sealed Tenders along with product details in a two bid system are to be deposited in the Tender Box placed in the office of the Commandant. 11 Bn NDRF, M A Road, Chowkaghat, Varanasi-221002 (UP), on or before **13 Feb' 2016 at 1200 HRS.**
2. Envelops should be super scribed with the Tender No. and Date.
3. Tenders will be opened in the presence of the bidders on **13 Feb' 2016 at 1600 HRS.** by a duly approved Board of Officers.
4. Improper or incomplete Tenders or Tender without specifications will be rejected.
5. All tenders are to be accompanied with a Demand Draft of **Rs.13,000/-(Rupees thirteen thousand)** only drawn in favour of the Commandant 11 Bn NDRF, payable at SBI, **payable at SBI, Hotel De-Paris (Varanasi), Varanasi Cantt. (code No: 04558).** This is to be retained as Earnest Money from the bidders.
6. Bank Drafts of unsuccessful bidders will be returned after the completion of the bidding process.
7. Bidders are to produce detailed product specification of the items, rate for which has been quoted. Price offered should be inclusive of all taxes/packing and freight and F.O.R. Varanasi (UP) but excluding of Central Sales tax, which may be indicated separately.
8. All tenders without detailed product specification will be rejected.
9. **The tender process will be in TWO BID SYSTEM under rule GFR 152. In the first cycle only product specification conforming to the specifications will be selected. And further only quotations of tenders whose product specification have been selected, will be entertained.**

10. All bidders are requested to submit their offers in two covers as under:

a) **FIRST COVER** should contain the following: -

- i) Tender documents duly completed and signed  
BUT WITHOUT INDICATING THE RATES QUOTED.
- ii) Earnest Money (If applicable)
- iii) F O R, terms, delivery period quoted.
- iv) Copy of firm registration and Dealership certified
- v) Any other relevant document which the firm wishes to submit.
- vi) Tender Sample/proof of having submitted tender sample.
- vii) Specification of the product.

b) **SECOND COVER** should contain the following: -

- i) Details of rates, taxes, duties, discounts, if any, quoted by the bidder. These details should be submitted on their letter pad.
- ii) Both the above mentioned covers should be sealed separately and super-scribed with the Tender No, stores and date of tender opening.
- iii) These covers should thereafter, be kept in a third cover and again sealed.
- iv) This cover should also be super scribed with the Tender No, Stores and Date of Tender Opening.
- v) The composite bid i.e. rates indicated in the Technical Bid OPENLY IN TENDER IS LIABLE TO BE IGNORED.
- vi) Rate quoted by the firm should be on firm price basis.

(Only the first cover shall be opened on the date of opening. Price bids of only those firms will be considered for tender opening whose offer is complete in all respects and the tender samples submitted by them are approved/qualified by lab test)

11. All tenders are to be accompanied with a copy of the Sales Tax Registration and VAT Registration of the firm.
12. Successful tenderers should supply the material within 30 days from the date of receipt of the supply order.
13. **Successful bidders will have to supply the Goods within 30 days of placement of Supply Order by this office, On intimation they are required to provide advance sample before placement of supply order or supplying the whole consignment for assessment and also deposit 10% of the amount of total cost of goods as security deposit by Bank Draft, which will be returned after full and satisfactory supply of the goods.**

14. This period may be extended for further 15 days in case of any delay due to any unnatural circumstances at the sole discretion of the Commandant 11 Bn NDRF.
15. Commandant, 11 Bn NDRF has the power to reject any tender or all tender without assigning any reason or extend the date of opening of tender without citing any reasons. Decision of Commandant 11 Bn NDRF will be final and binding to all Tenderers.

### **SPECIFICATION OF REGULAR OXYGEN LSP# 170-020 WITH LIGHT WEIGHT OXYGEN CYLINDER**

#### **QUALITATIVE REQUIREMENTS**

##### **Oxygen cylinder**

- The medical oxygen cylinder should be made of high quality &
  - ✘ Strength of aluminum alloy with heat sensitive coating.
  - ✘ Capacity : 425 ltrs approx.
- The manufacturer must have ISO or equivalent certificate for design and manufacturing of aluminum oxygen cylinder and for quality management system.
- It should be duly approved by the Chief controller of Explosive (CCE). Manufacturing certificate.
- The system should be rust proof.
- The refilling procedure should be risk free and simplex, with the help of portable refilling station complete with pressure gauge to show filling pressure.
- All fittings should be leak proof.
- In built pressure gauge system to be provided with the cylinder.
- The medical Oxygen cylinder and all other fittings should be hygienic and free from contamination.

## **Regulator**

- Accessories : high pressure regulator , flow meter, connecting tube of Approx 3 meter length approx, nasal canola and non re-breather mask – adult and infant sizes, carry pack with back harness.
- Compatible with light weight oxygen cylinder.
- Flow regulator of 0-20 L/ Minute approx.
- Outlet compatible with nasal canola / non re-breather mask.
- Control valve should be designed to provide calibrated flow of oxygen at a pressure of 16 PSIG to 70 PSIG depending on the application.
- The regulator must be made of anodized aluminum composite material.
- The pressure indicator on the valve must be protected by rubber o- ring.
- The weight of the regulator inclusive flow meter system should not exceed 310 gms approx.
- The length of the regulator should not exceed 10 cm & diameter not to be more than 4 cm approx.
- Hypoallergenic surgical micro pore adhesive tape.

## **NOTE TO TENDERER**


- i) The product be CE marked.
- ii) The manufacturer must have ISO or equivalent certificate for design & manufacturing of medical device.
- iii) The ISO or equivalent certificate for quality management system.
- iv) The tenderer shall indicate the make/model in their offer.
- v) The tenderer shall furnish the clause-by-clause compliance statement. In case there is any deviation the same should be clearly brought out in the offers.
- vi) They shall mention the relevant BIS/EN/DIN/UL certificate of the product offered.
- vii) Technical manual comprising of servicing details shall be supplied with system.
- viii) Items will be purchased on the basis of quality, price and samples. Rates should be valid till **31<sup>st</sup> March-2016**.
- ix) Tender received without sample will not be entertained.
