Authorized dealers/distributors should attach a certificate of Authorized Dealership/ distributor along with their bid. 3. Certificate of Authorized Dealership / Distributorship must be valid at least for 01 year from the date of opening of the Tender.	01.	Page No. 5 & 28, Eligible And Qualification Criteria:- Bidder should submit self-declaration certificate stating that kit will be supplied as per required specifications.
02	Page No. 18: : Contents for Male Dignity Kit (Technical Specification):-	02	Page No. 18: : Contents for Male Dignity Kit (Technical Specification):- Note:- In addition to the specifications mentioned in TE following are clarified that:- "All item of dignity kit should be branded/ISO certified. Undergarment (02 piece each) in cotton fabric & Kurta and Payzama with mix fabric (65% Cotton & 35% polyester $\pm 10\%$) pastel in colour are required in three different sizes i.e. Medium, Large & Xtra Larg. The size wise quantity will be decided at the time of issue of AT. Cotton fabric bathing towel is required with minimum weight of 250 gm. Weight and number of the different Kit item wherever mentioned are minimum. But items supplied excess of minimum weight and number will be accepted. However, as per para 13.4 of GCC of TE, suppliers should supply best quality store without any defect. Hence, sample kit should be of best quality so that it would be easy for comparing the items in PE".
